THE BOROUGH OF READING (BUS LANES)  
TRAFFIC REGULATION ORDER 2006

The Reading Borough Council (hereinafter referred to as "The Council"), pursuant to its powers under Sections 1(1),2(1) to (3), 4(1) and Part IV of schedule 9 to The Road Traffic Regulation Act 1984 (The Act of 1984) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby make the following Order :

1. This Order may be cited as "The Borough of Reading (Bus Lanes) Traffic Regulation Order 2006 " and shall come into operation on 4<sup>th</sup> September 2006

PART I  
GENERAL

2. Definitions

In this Order:-

"Authorised Cab Rank" means any area of carriageway which is comprised within and indicated by a road marking complying with Diagram 1028.2 in Schedule 6 to the Traffic Signs Regulations and General Directions, 2002;

"Bus" has the same meaning as in Regulation 22 of the Traffic Signs Regulations and General Directions 2002;

"Bus Lane" has the same meaning as in Regulation 23 of the Traffic Signs and General Directions 2002 (which also includes sign nos. 953, 958, 959 or approved variants);

"Carriageway" means a way constituting or comprised in a highway being a way (other than a cycle track) over which the public have a right of way for the passage of vehicles;

"Cycle" means a bicycle, tricycle, or cycle having four or more wheels, not being in any case a motor vehicle;

"Cycle Lane" means the length of road specified in this Order as a cycle lane and bounded by delineating road markings as described under The Traffic Signs and General Directions 2002;

"Delivering" and "Collecting" in relation to any goods includes checking the goods for the purpose of their delivery or collection;

"Goods" means goods or burden of any description and includes postal packets of any description;

"Goods Vehicle" means a motor vehicle which is constructed or adapted for use for the carriage of goods or burden of any description and which does not exceed 5.30 metres in length or 2.25 metres in height;

"Hackney Carriage" means a vehicle licensed under Section 37 of the Town Police Clauses Act 1847, Section 6 of the Metropolitan Carriage Act 1869 or any similar enactment;

"Immobilisation device" has the same meaning as in Section 104(9) of the Road Traffic Regulation Act 1984;

"Motor Cycle" and "Invalid Carriage" have the same meanings as in Section 136 of the Road Traffic Act of 1984;

"Owner" in relation to a vehicle means a person who is named in the vehicle registration document as the registered keeper of a goods or passenger vehicle or who has the use of such a vehicle in the course of his employment and who is entitled to use such a vehicle as though he were the registered keeper thereof;

"Parking Attendant" means a person authorised by or on behalf of the Council to supervise any parking area;

"Passenger Vehicle" means a motor vehicle (other than a motor cycle or invalid carriage) not exceeding 5.30m in length and 2.25m in height and constructed for the carriage of passengers and their effects;

"Penalty Charge" and "reduced penalty charge" means a charge set by the Council under the provisions of The Bus Lane Contraventions (Penalty Charges, Adjudication and Enforcement) (England) Regulations 2005 and with the approval of the Secretary of State for Transport which is to be paid to the Council within 28 days beginning with the date of the notice, or 14 days in the case of a reduced penalty charge, following the issue of a penalty charge notice;

"Penalty Charge Notice" means a notice issued or served by the Council pursuant to the provisions of regulation 8(1) of The Bus Lane Contraventions (Penalty Charges, Adjudication and Enforcement) (England) Regulations 2005;

"Taxi" for the purposes of this Order has the same meaning as Hackney Carriage given above;

"Telegraphic Line" has the same meaning as in the Telecommunications Act, 1984;

"The 2002 Regulations" means the Traffic Signs Regulations and General Directions 2002;

"Traffic Sign" means a sign of any size, colour and type prescribed or authorised under, or having effect as though prescribed or authorised under Section 64 of the Act of 1984;

"Traffic Warden" means a Traffic Warden employed by a Police Authority in pursuance of Section 95 of the Act of 1984.

"with-flow lane" means a traffic lane reserved for a specified class of traffic proceeding in the same direction as general traffic in an adjoining traffic lane;

"contra-flow lane" means a traffic lane reserved for a specified class of traffic proceeding in the opposite direction as general traffic in an adjoining traffic lane.

## PART II PROHIBITED MOVEMENTS

3. No person shall, except upon the direction or with the permission of a Police Constable in uniform or of a Traffic Warden, use a vehicle or cause or permit any vehicle except a bus to be in the bus lane specified in Schedule 1.
4. No person shall, except upon the direction or with the permission of a Police Constable in uniform or of a Traffic Warden, use a vehicle or cause or permit any vehicle except a bus or cycle to be in the bus lane specified in Schedule 2.
5. No person shall, except upon the direction or with the permission of a Police Constable in uniform or of a Traffic Warden, use a vehicle or cause or permit any vehicle except a bus, cycle or taxi to be in the bus lane specified in Schedule 3.
6. No person shall, except upon the direction or with the permission of a Police Constable in uniform or of a Traffic Warden, use a vehicle or cause or permit any vehicle except a bus, cycle, taxi or motorcycle to be in the bus lane specified in Schedule 4.
7. No person shall, except upon the direction or with the permission of a Police Constable in uniform or of a Traffic Warden, use a vehicle or cause or permit any vehicle except a bus or cycle between the hours of 7.30am and 8.45am Monday to Friday inclusive to be in the bus lane specified in Schedule 5.
8. No person shall, except upon the direction or with the permission of a Police Constable in uniform or of a Traffic Warden, use, cause or permit any bus, cycle, hackney carriage or motorcycle as the case may be to proceed along a bus lane, otherwise than in the direction specified in

column 3 of Schedule 1, 2,3, 4, or 5 in relation to that length of road.

9. No person shall, except upon the direction of a Police Constable in uniform or of a Traffic Warden, cause or permit any vehicle proceeding along a bus lane in accordance with Article 8 to cross over the white line unless it is necessary to do so in order to overtake a vehicle which is stationary in the bus lane.
10. Nothing in the foregoing Articles 3,4,5,6, 7 and 8 shall prevent any person causing or permitting any vehicle to be in a bus lane in the direction specified in Schedules 1,2,3,4, and 5 as the case may be, insofar as it is absolutely necessary, to enable the vehicle to be used for any of the purposes set out hereunder or to wait in the bus lane for so long as may be necessary for any of those purposes:-
  - (a) the removal of any vehicle or to effect emergency repairs to a vehicle in the bus lane so as to relieve any obstruction.
  - (b) Police, Fire Brigade or Ambulance purposes; or
  - (c) the service of any local authority or water authority in pursuance of statutory powers or duties; or in connection with the supply of gas or electricity, or any telecommunications system as defined in the Telecommunications Act, 1984.
11. Nothing in Article 8 shall prevent any person causing or permitting any vehicle:-
  - (a) To enter or be in a bus lane for any of the purposes set out in paragraphs (i) to (iii) below, by crossing the white line, at a point opposite that person's destination, or a point as close as possible to that point, provided that such entry is absolutely necessary in respect of:-
    - (i) the gaining of access to off-street loading or garaging premises adjacent to or accessible only from the bus lane;
    - (ii) the loading or unloading of any goods or burden at these premises adjacent to or accessible only from the bus lane; provided that such loading or unloading can reasonably be carried out only from the bus lane and that it takes place only whilst no prohibition on loading or unloading in the bus lane by virtue of any other order is in force;
    - (iii) the removal of any obstruction to traffic in the bus lane; or
  - (b) In the service of any local authority or water authority in pursuance of statutory powers or duties to be in the bus lane;

- (c) which is to be used in connection with the maintenance, improvement or reconstruction of any lengths or road, or the laying, erection, alteration or repair in or near any of the lengths of road of any sewer or main, pipe or apparatus for the supply of gas, water, electricity or telegraph line to be in the bus lane;
  - (d) having entered a bus lane in accordance with (a) above, to wait therein for the purposes set out in (i), (ii) and (iii);
  - (e) having entered a bus lane in accordance with (a) above, to leave the bus lane by crossing the white line at a point as close as possible to the point of entry.
12. No person shall, except upon the direction of a Police Constable in uniform or of a Traffic Warden, cause or permit any vehicle other than a bus to enter or be in the length of road specified in Schedule 6.
  13. No person shall, except upon the direction of a Police Constable in uniform or of a Traffic Warden, cause or permit any vehicle other than a bus or cycle to be in the length of road specified in Schedule 7.
  14. No person shall, except upon the direction of a Police Constable in uniform or of a Traffic Warden, cause or permit any vehicle other than a bus, cycle or hackney carriage to be in the length of road specified in Schedule 8.
  15. No person shall, except upon the direction of a Police Constable in uniform or of a Traffic Warden, cause or permit any vehicle other than a bus, or cycle between the hours of 7.30am and 8.45am Monday to Friday inclusive to be in the length of road specified in Schedule 9.
  16. Nothing in Articles 12, 13, 14 or 15 shall prevent any person causing or permitting any vehicle to enter or be in any of the specified lengths of road in so far as such entry is absolutely necessary to enable that vehicle to be used for
    - (a) the removal of any bus or to effect emergency repairs to a disabled bus so as to relieve any obstruction to those said lengths of roads, or
    - (b) for Police, Fire Service or Ambulance purposes.

PART III  
CONTRAVENTION OF ORDER

16. (1) If a vehicle is in an area of road which is or forms part of a bus lane in contravention of any provision of this Order, a penalty charge shall be payable pursuant to Section 144 of the Transport Act 2000.

- (2) In the case of a vehicle in respect of which a penalty charge is payable, a penalty charge notice showing the information required by section 8 (5) of the Bus Lane Contraventions (Penalty Charges, Adjudication and Enforcement)(England) Regulations 2005 may then be issued by the Council in accordance with section 8(2) and (5) of the said Regulations.

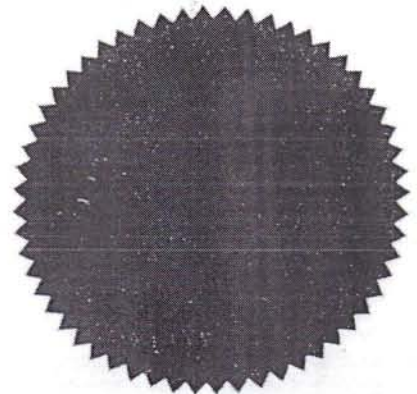
