READING BOROUGH COUNCIL Consultation with Schools: Reading Schools Funding Formula for 2018-2019

September 2017

Introduction

The purpose of this consultation is to gather views from **primary and secondary** schools and other interested parties (including academies) on proposals for changing school funding arrangements in Reading. These proposals have been prepared following a review of the formula for 2018-19 by the local authority and a sub-group of the Schools' Forum.

This consultation concerns the Dedicated Schools Grant (DSG) and the distribution of this through the local funding formula. It is relevant to all primary and secondary maintained schools, academies and free schools in Reading.

There is widespread recognition that the current schools funding system is unfair and out of date. Whilst the DfE remains committed to addressing this, the introduction of a National Funding formula has been consulted on twice and as yet we have not heard about the final arrangements for 2019-2020 or any implementation for 2020-2021.

The latest information states that the government is proposing to introduce the national formula in two stages. These stages are called 'soft' formula and 'hard' formula.

- In 18-19 and 19-20, the soft formula will be introduced. This would mean that Reading will be funded as though the formula was being introduced but the LA has full control over the formula and should use these years as a transition to help schools move to the national formula.
- In 20-21, the hard formula will start and this would mean no local control and the schools will receive funding as stated by the government and not the LA. There will be some minor local input for business rates and other exceptions.

As the Reading formula has not been reviewed since 2014 and the potential changes in National Funding system, it was agreed by the LA and Schools' Forum to review the formula to help transition to any potential national formula and to review any unique traits that Reading has adopted over the years.

The LA intends to change the formula where it deviates substantially from other LAs, for example with regard to the IDACI Factors which is currently not used by Reading, but will be in the National Formula and is used by the majority of LAs in the country, while adhering to the principle of limiting turbulence as far as possible.

In addition, we have taken account of proposed National Funding factor values to help shape the transition of schools moving to the National formula in 2020-2021.

If headroom is available this may be used in part to fund the changes proposed, in addition to shifting funding from one factor to another. Clearly this will be subject to other funding priorities to be discussed with Schools' Forum in due course.

We have undertaken extensive modelling/ impact assessment of any potential changes in this paper. As always it is important to note that whilst these are based upon historic data these will be subject to change and therefore the figures need to be treated with caution and are indicative only. It is also important to note that we have modelled changes exclusively. In reality any school facing reductions under the proposed changes will lose less funding in total due to the operation of the Minimum Funding Guarantee.

National Funding Formula

- The Department for Education (DfE) has recently published its detailed consultation on proposals to move Schools' and High Needs funding onto a National Funding formula (NFF) from 1 April 2018. This report provides details on the key proposals as well as highlighting the impact of these proposals on Reading schools and academies.
- The latest consultation focuses on the weightings between the factors and the amount of funding to be channelled through each factor.
- The rationale for moving to a NFF is that the current system is unfair and not transparent with similar schools and local areas receiving very different levels of funding, with little or no justification. The DfE view is that the current National Funding inequality is further compounded by the application of a local formula.

Government Proposals

- From 2018-19, the Dedicated Schools Grant (DSG) will be split into four blocks rather than three Schools, High Needs. Early Years and the new Central services for schools
- The government intends to operate a 'soft' National formula in 2018-19, which means that the local authorities will still be responsible for producing a local formula for maintained, academies and free schools in Reading.
- From 2020-21 the introduction of a 'hard' National formula will be implemented that means very little flexibility and control for the local authority. The government plans to provide further details on this local flexibility in due course.
- Within 18-19 (soft year) the new National Funding formula will be applied at school level and fed up to one overall allocation for the local authority for distribution through a local formula. Annex 2 (page 14) provides the proposed rates and formula factors to be used and compared to Reading's own factors and unit amounts.
- For 18-19 (Soft), the government has confirmed that LAs will be able to move funding between the Schools Block and High Needs Block. Following local consultation and with the explicit agreement of the Schools' Forum and the majority of their schools. Some continued local flexibility may exist from 19-20 but no details have been published.

9 DfE Proposals

- Continue to have 12 factors with the school formula.
- Maintain the Primary to Secondary ratio in line with the current national average (1:1.29). This means Secondaries would on average receive 29% more funding per pupil than Primaries. (Reading Currently 1:1.25, 25%)
- Continue to increase the basic rate as pupil's progress through the key stages.
- Continue to provide every school with a Lump sum (£110,000)
- To fund NNDR, Premises factors and School Growth in 18-19 on the basis of historic spend.
- Increase the proportion of funding allocated to pupil led factors/characteristics.

Transition to the New Formula

- The DfE proposes to build in an overall 'funding floor', in addition to the current MFG (to remain at minus 1.5%), so that no school will face a reduction of more than 3% per pupil overall as a result of the changes.
- Schools that gain within the new formula will be capped at 3% in 18-19 and then capped up to a further 2.5% in 19-20. This has been made possible by the DfE increasing the allocation to the Dedicated Schools Grant each year. This increase will be supplied to the gaining LAs who will then, consult and agree with Schools' Forum on the soft 18-19 local formula.

Financial Impact for Reading

Based on the initial review of the indicative data provided by the DfE alongside the consultation, Reading appears to be gaining in the region of £2.1m prior to any transitional protection being applied. After Transitional protection the gain reduces to £1m. See table below

At an individual school level, the most significant change affecting school budgets is the funding allocation for Additional Needs. The DfE is proposing to increase the percentage of funding going to characteristics of pupils rather than the basic entitlement. Table below shows the average percentage changes between AWPU and other Formula factors.

PROPOSED CHANGES

QUESTION 1

<u>Should Reading implement the IDACI factor within the 18-19 local formula?</u>

What is IDACI?

The Income Deprivation Affecting Children Index (IDACI) is part of the Indices of Multiple Deprivation (IMD). It is an area based measure defined at the level of Lower Super Output Area (LSOA). It takes the form of a score between 0 and 1, which can be interpreted as the proportion of families in LSOA, with children aged under 16, which are income deprived.

The IDACI score has been matched to pupil records where the pupil's postcode is known, and this has been placed into 6 bands as shown below.

Only pupils with an IDACI score above 0.2 can be assigned deprivation funding through this factor meaning there are six bands which can be given different unit values each for Primary and Secondary phase pupils e.g. a child with an IDACI score of 0.3 is 30% likely to be from a deprived background.

Since 2014-15, 95% of Local Authorities already use the IDACI indicator for the deprivation factor. This will be used in the new National Funding formula. During the last funding formula consultation (2014) Reading was close to implementing the change but the consultation from schools came out at 50/50. Due to this, the LA decided not to include this factor.

If IDACI was implemented, all schools will gain from this factor due to it being new. This factor will be funded from other factors reducing e.g. AWPU/FSM or using any unallocated funds. <u>See Annex 3</u> (page 16) on how much each school would have received through this factor in 17-18. We have used 50% and 100% of the current national factor values.

QUESTION 2

Should Reading change the free school meal factor from 'on the day' to Ever 6 criteria within the 18-19 local formula?

Reading has used the 'on the day' free school meals data since 2013 and has heavily funded this factor. This has been the only deprivation factor within Reading formula and as part of this exercise we looked at moving funds from the current factor and start using Ever 6 Free School Meals and at the intended national rate. This will decrease the funding overall as the unit rates are on average 66% lower but the number of pupils eligible would increase by around 82%.

The funding will still be lower overall, but this is due to the potential introduction of the IDACI Factor that will see funds from free school meals and AWPU being used.

Ever 6 is used for Pupil Premium calculations. The Schools Funding Formula Working group thinks this is more focused on deprivation if Ever 6 is used. The funding rates will reduce if IDACI is implemented at the same time.

Annex 4 (page 17) shows how much schools would receive if we use the full national funding values for Ever-6 compared to the current 'on the day' free school meals that schools received in 17-18.

If IDACI is implemented (question 1) then this factor with Ever 6 Free school meals indicator would total the new deprivation allocation. We have showed this is <u>Annex 4</u> (page 17) to give an idea what impact it would have on individual schools.

QUESTION 3

<u>Should Reading increase the Lump Sum to the draft National Funding rates?</u>

Reading has the lowest lump sum in the country but with the introduction of the National formula, this factor will be increased.

In previous local formula reviews, the LA and Schools' Forum working groups have agreed not to increase the lump sum due to the consistent types of schools within an urban local authority.

Currently the lump sum is £48,480 per school in Reading local formula (Approx. £2.4m) With the national funding formula the new lump sum will be £110k per school (Approx. £5.4m)

Changes to the lump sum will continue to be protected by the minimum funding guarantee (MFG) as they are now.

Funding has to be found within other factors unless we can use additional funding promised via the government.

The table below states some for and against arguments that have been discussed over the years.

Arguments for	Arguments against
Bring the LA in line with most other LAs.	An increase funded by reductions in 'per pupil' funding would cause turbulence with funding allocations.
Meet Schools' Forum concerns regarding the future financial viability of the smallest schools.	The smallest schools have been protected by MFG funding so far with as yet no evidence of the smallest schools becoming financially unviable
Assists on Transition arrangements towards the National Formula in 19-20	It can be argued a larger lump sum in a formula for schools in an urban LA such as Reading would lead to increased inefficiency as the incentive for small schools to seek economies of scale through, for example amalgamation, would be reduced.

QUESTION 4

Should Reading prepare for the National formula and start moving towards the national funding rates that are currently shown in Annex 2?

The government has stated that the National Funding Formula will be implemented in 2020-21 and to assist schools in transitioning to the National formula we would like views on moving factor values from Reading set amounts to the National rates.

In previous questions we have discussed changing factors rather than the unit values of each factor. Annex 2 (page 14) shows the government's current National funding values for factors and it shows Reading's Current 17-18 values.

The LA has two years to help schools deal with the change in funding and Reading LA's ultimate goal is not to disrupt schools funding too quickly, but to gradually transition to the implementation of the National Funding Formula.

<u>Annex 5</u> (page 19) shows the current funding allocations if we implemented the National Formula from 18-19 vs the current 17-18 funding figure.

If Reading moved to the national formula from 18-19 without receiving additional funding then all Primary schools would lose funding and all Secondaries would increase, this is mostly due to the AWPU (Average Weighted Pupil Unit) reducing by 13% for Primaries and only 1% for Secondaries.

Implementing the change would have huge consequences regarding the overall budget and so unit values will need to be adjusted over the next two years to assist on the impact to Primaries and waiting for the increase in funding to be supplied by the National formula.

DSG Funding allocations will not be notified until middle of December

There are many possibilities when producing the 18-19 Reading Schools Local Formula, and the ultimate goal is to balance the dedicated schools grant with a fair formula for all schools in the Reading Borough while implementing the national changes that are starting to come in for the National Formula in a few years' time.

QUESTION 5

If Reading could only change some elements of the formula in 18-19, which factors do you feel are more important? Please rate importance 1 to 5 with 1 being very important and 5 the least important.

Your choices would inform the LA on factor value changes when the formula work commences over the Christmas period to produce the fairest approach to implement the Reading schools local formula.

For example, if schools rate EAL highly important, then the LA will try its best to keep funding in this area. If EAL is not highly rated, then funds could potentially be moved to other areas, i.e. IDACI - if this is decided to be implemented.

Overall the LA has a duty to balance the schools formula and will report back to Schools' Forum in January 2018 with details for discussion.

Next steps – results of consultation

• The results of this consultation will be reported to the Schools' Forum members on the Thursday 19th October 2017.

- The changes are an LA decision but clearly this is subject to consultation with Schools' Forum before senior officers makes the final decisions on the formula to be used in 2018-19.
- The local funding formula for 2018-19 will be finalised based on affordability of the 2018-19 DSG settlement and issued pupil data sets in late December 2017, for final submission to the EFA by Friday 19th January 2018. Individual school budget allocations will be confirmed to local authority maintained schools by Friday 23rd February 2018. The EFA will confirm academy budgets during February 2018.
