## 4. 2014/15 DSG BUDGET MONITORING Presented by SD

- Last time reported 1.3m overspend on High needs block, remains unchanged
- Work completed on funding; found a few more savings (approx. 100K)
- Civatas Academy opening in September 2015 need to find 150K to cover the opening costs; this is a Reach 2 school (not a free school); additional savings to help fund this; 150k made in 2 payments
- Stay on target; 900K overspend due to High Needs Block

- Same as reported last time
- 50k underspend being transferred to High Needs Block

# 5. SCHOOLS IN FINANCIAL DIFFICULTY FUND CRITERIA AND BID FROM ST ANNES RC PRIMARY

Presented by RD; Vice Chair CC to continue with this as Chair is involved in one of the schools

(PART 1)

- Recall a de-delegation to set up fund called "schools in financial difficulty"
- Identified schools
- Looked at what other local authorities do and they have similar funds
- License deficient for school
- Schools Forum to agree the criteria; 50K fund
- Question asked if this fund amount was tangible; 50K is probably at the lower end
  of what other authorities had and felt it is sufficient
- Reason for OFSTED RI judgement? Used what other authorities have done.
- KMD this idea is to act sooner so the children will benefit quicker
- If the school has had to make a structural change (formal warning or removed a governing body); this came from experience with particular schools
- This is structural costs

# 6. GROWTH FUND ADDITIONAL CRITERIA AND BID FOR FUNDS FROM CIVITAS ACADEMY Presented by RD

- Suggestions for criteria for this new aspect of Growth Fund

- Starting on a temporary location (cost involved with this)
- Building and furniture will come out of capital this is coming from the revenue budget

- Terms of reference the group outlined; Structural savings; spectrum of provision and spectrum of resources that both currently exist to see what works and what doesn't:
- Requested a short life working group (2 x 2 hour meetings) specialist provision
- Do you have a good idea about a not so good provision; Group will research 'impact'
- KMD updates on Peter Gray who was employed to do a report before Christmas; This will be released to the working group and to Forum as soon as this is approved at council level
- Next meeting for group is next Wednesday

## 8, 2014/15 EARLY YEARS: UPDATE FROM EYSFF GROUP MEETING Presented by RD

- Update from last Schools Forum
- Discussions and agreements at this meeting
- Rates payable early years single funding formula; benchmarking done previously
- Look at Block Funding in particular Nursery Schools
- Funding on an equitable basis
- Agreed rates set out in Table 2
- 2 year old placements have increased (one of the highest increases is in the South East)
- 2 year old funding in the Coley area
- Speech and Language contract; this will roll on for another year but this needs to be reviewed thoroughly to justify value for money (this change is approximately a year away)
- Hold back contingency; Scope to release around 800K, potentially could be transferred to the High Needs Block; this decision will be made by the Local Authority
- There is a need to work more closely (Early Years and High Needs Block)
- Early Years needs block amount has not been quantified
- Once the money has been used it can be recovered

## Presented by SD

### FUNDING FOR MEDICAL PUPILS

- Medical pupils a few years ago Cranbury College used to a be part of the Local Authority and did a few functions for them
- Now Cranbury College separate body
- Medical pupils mostly referred with mental health issues and mostly effects secondary aged students; this student needs to be supported with medical evidence
- In the past the Cranbury College budget paid for this; this should no longer be the case
- There is no funding to Cranbury College to support this but Cranbury College are still doing quite a lot of support
- Medical pupils come under the high cost category
- Medical pupils given support should be that the first 6K needs to be funded by the home school after this will be picked up via a panel
- Currently Cranbury College paying for all of this and there is no funding
- There will be a letter/email sent out to School's Forum
- NM suggests that secondary schools get together with Cranbury College (Marianne) and discuss this further
- Does the money come from High Needs Block?
- There needs to be clarity on what is being offered by Cranbury College for the money. MB advises that this is variable depending on the child's needs
- VA also advises that Health needs to be included in this process as well

## ACTION(s)

- VA and NM to arrange a meeting with secondary heads and MB (and other representatives) of Cranbury College to discuss this further
- KMD to speak to CS and Health Service to identify who needs to be present at this meeting
