**For:** Outline planning permission with the details of access, appearance, landscaping, layout and scale reserved for later determination. A demolition phase and phased redevelopment (each phase being an independent act of development) comprising a flexible mix of the following uses: Residential (Class C3 and including PRS); Offices (Use Class B1(a); development in Use Classes A1, A2, A3 (retail), A4 (public house), A5 (take away), D1 and D2 (community and leisure); car parking; provision of new plant and renewable energy equipment; creation of servicing areas and provision of associated services, including waste, refuse, cycle storage, and lighting; and for the laying out of the buildings; routes and open spaces within the development; and all associated works and operations including but not limited to: demolition; earthworks; provision of attenuation infrastructure; engineering operations.

With reference to the above appeal, I am writing to inform you that the Inquiry is to be held as an in-person event on day 1 (with the facility to participate virtually) and that the remainder of the inquiry will be entirely virtual. Opening at <u>10:00am</u> on Tuesday 26 April 2022, and scheduled for 12 days. The duration is not fixed and will depend on how the evidence emerges.

The Inquiry will be held as a virtual event run by an Inspector in the normal way, but with the parties invited to join via Microsoft Teams or telephone.

S Heywood BSc (Hons) MCD MRTPI has been appointed by the Secretary of State to determine this appeal; and this Inspector will preside at the hearing.

Anyone wishing to attend the Inquiry must make that interest known to the Planning Inspectorate Case Officer and the LPA as soon as possible prior to the Inquiry, either by email or telephone after reading the Attendance Information set out below.

If you wish to take an active part in the proceedings, please make clear in your response the particular topic areas you are interested in, whether you wish only to appear at the Inquiry and make a statement, or whether you would also wish to ask questions on particular topics. If you want to take an active part but feel unable to for any reason, and/or the points you want to make are not covered in the evidence of others, consider whether someone else could raise them on your behalf.

Registered participants in whatever capacity will receive individual joining instructions, providing details of any requirements, guidance and support, whether joining by Teams or telephone.
