








LF Figure 3. 55 Vastern Road Appellant's analysis of the directness of potential pedestrian routes




LF Figure 6. Extract from Reading Station Area Initial Development Framework (RBC) -Figure titled: 'Connecting the City from the Kennet to the Thames'



LF Figure 7. Appeal site, 80 Caversham Road and 55 Vastern Road scheme building footprints






LF Figure 9. Appeal Illustrative Scheme heights




LF Figure 10. Key public spaces in Central Reading (Kennet-Thames Spine shown as a dotted red line)




LF Figure 11. Landmark buildings in Central Reading, their public space setting and views towards them


LF Figure 15. Sequence of views ('kinetic views) of the RSAF illustrative scheme travelling along Queens Victoria Road and Station Road towards the station




LF Figure 16. RSAF Illustrative scheme view from caversham Road




LF Figure 18. View east along Vastern Road showing ground level building setbacks and arcades



LF Figure 19. Vastern Road massing showing the Appellant's parameter plan heights and massing




LF Figure 20. RSAF Illustrative scheme




LF Figure 23. Collage of Illustrative masterplans for the Appeal Site, 80Caversham Road and 55 Vastern Road



LF Figure 24. Sketch 3d model of Appeal Illustrative scheme and NS link alignment from the station to the River




LF Figure 25. Sketch 3d model of Appeal Illustrative scheme and NS link alignment from the River to the station




LF Figure 26. Sketch 3d model of Appeal Illustrative scheme and NS link alignment viewed form the north west




LF Figure 27. RSAF Illustrative framework buildings overlaid on the Parameter Plan.








LF Figure 30. RSAF Vaastern Road alignment traced over Parameter Plan.




LF Figure 31. Appellants parameter plan heights (yellow) overlaid with Appellant's illustrative scheme massing (white).




LF Figure 32. Appellants parameter plan heights (yellow) overlaid with RSAF illustrative scheme
