# Welcome to Reading Borough Council's Parking Services Annual Report for 2023/2024

# Supporting Sustainable Travel and Effective Parking Management in Reading

Reading Borough Council is dedicated to creating a cleaner, greener, and more connected community by promoting healthy lifestyles, enabling sustainable growth, and tackling the challenges of an evolving urban environment. As Reading continues to grow, we face significant issues such as congestion, climate change, air quality concerns, and a rising population. Proactive parking management is a critical tool in addressing these challenges, encouraging sustainable travel choices, and ensuring our transport networks remain effective and accessible.

# Parking Management: A Strategic Approach

Without effective management, parking can disrupt traffic flow and prioritise individual convenience at the expense of the wider community. Our parking strategy is designed to mitigate these issues through:

- Time restrictions and controlled parking zones to balance demand.
- Parking charges to fund transport-related initiatives.
- Residents' parking permits and Blue Badges to ensure fair access for all, including less mobile residents.

By managing both on-street and public car park provision, we aim to encourage sustainable travel patterns while supporting an inclusive and equitable approach to mobility.

# **Key Responsibilities of Parking Services**

The Parking Services team plays a pivotal role in maintaining compliance with parking and traffic regulations, which contributes to safer roads and reduced congestion. Their responsibilities include:

- Enforcing parking and traffic regulations, including moving traffic rules introduced in early 2023.
- **Managing off-street car parks**, including maintaining partnerships for Park & Ride facilities and ensuring payment machines are functional.
- **Issuing permits** for residents and workers and overseeing the equitable allocation of parking resources.

#### Transparency and Public Accountability

We are committed to being open and transparent about our Parking Services operations and enforcement activities. This annual report for the 2023/2024 financial year outlines our work, achievements, and ongoing efforts to foster understanding and acceptance of enforcement's essential role. Our goal is to support sustainable travel and maintain an efficient and effective transport infrastructure for all who live, work, and visit Reading.

# **Chapter 2 - Policy Context**

Reading Borough Council began parking enforcement in 2000, taking over responsibility from Thames Valley Police. Enforcement of parking and waiting restrictions is carried out under the Traffic Management Act 2004, which introduced Civil Parking Enforcement (CPE). This legislation classifies parking offences as civil rather than criminal, allowing local authorities to enforce restrictions more effectively.

The Council manages an integrated Parking Service, overseeing both on-street and off-street parking. Civil Parking Enforcement, under Part 6 of the Traffic Management Act 2004, was introduced in Reading on March 31, 2008. This service was expanded in 2022 to include Moving Traffic enforcement and updated Bus Lane enforcement legislation, previously governed by the Transport Act 2000.

The guiding policy for transport in Reading is the **Local Transport Plan (LTP)**, **Reading Transport Strategy 2040**, adopted by full Council on 15 October 2024. The Strategy outlines a vision to create healthier, greener, and more equitable communities by promoting sustainable travel options as alternatives to private cars. It details plans for transport development up to 2040, aiming to support objectives like improved health and well-being, economic growth, reduced social inequality, better air quality, and addressing the Climate Emergency.

While the specific impact of Civil Parking Enforcement on these objectives cannot be directly measured due to various influencing factors, effective enforcement plays a key role in supporting this vision by fostering safer, more accessible, and well-regulated transport systems.

# **Chapter 3 - Parking Enforcement**

#### **Civil Enforcement Officer Training**

Reading Borough Council's Parking Services oversees parking enforcement both onstreet and off-street through Civil Enforcement Officers (CEOs). These officers are employed via a contractor and are provided with specialised training to ensure they are fully qualified for their role.

Each officer is required to achieve the **CIWM (WAMITAB) Level 2 Award for Parking Enforcement Officers**, a recognised qualification that equips them with the knowledge and skills necessary to enforce parking regulations effectively and professionally.

This rigorous training ensures that enforcement is conducted to high standards, supporting compliance with parking and traffic legislation, and maintaining the smooth operation of the Borough's transport network.

Civil Enforcement Officers (CEOs) are salaried employees and do not participate in any incentive schemes. Their sole responsibility in enforcement is to ensure that Penalty Charge Notices (PCNs) are issued correctly. This includes gathering and recording all necessary evidence, such as photographs, to support the enforcement action.

# **Use of Camera Enforcement (Approved Devices)**

The Traffic Management Act permits enforcement using approved camera devices in areas that are challenging or sensitive for on-foot enforcement. Our enforcement vehicles and static cameras are deployed to address contraventions of specific restrictions, including:

- School zigzag markings
- Bus stop clearways
- Red routes

This method is not used in situations where permits or exemptions, such as residents' permits or Blue Badges, may apply. The primary goal of camera enforcement is to promote road safety and ensure the smooth operation of the road network by deterring and detecting violations of parking restrictions.

# A Fair and Proportionate Approach to Enforcement

The Council's Parking Services team has a duty to review all aspects of each case carefully. As outlined in the Secretary of State's guidance, even when a clear contravention is identified, the Council retains discretionary authority to cancel a PCN. This practice adheres to general principles of public law, emphasising fairness, proportionality, and consideration of the public interest.

The guidance states:

"Under general principles of public law, authorities have a duty to act fairly and proportionately and are encouraged to exercise discretion sensibly and reasonably and with due regard to the public interest."

Discretion is exercised impartially, without regard to any financial implications of the penalty or prior decisions in the case. While this approach allows for PCNs to be cancelled when appropriate, not all motorists who contest their PCN will receive the outcome they desire. Decisions are made based on objective assessments and the specifics of each case.

# **Parking Restrictions and Compliance**



Parking restrictions are clearly marked by road signs and markings, such as:

- Yellow lines
- Loading bays
- Bus stops
- Residents' zones

These markings and signs indicate the specific rules that apply in each area. If these restrictions are breached, a contravention occurs, and a PCN may be issued.

#### **PCNs in Public Car Parks**

In Council-operated car parks, PCNs may be issued for the following reasons:

- Failing to pay the correct fee at a pay-and-display machine.
- Exceeding the permitted parking duration.

Additionally, vehicles causing safety hazards, congestion, or obstructions may be removed by the Police.

# **Responsibilities of Drivers**

It is the responsibility of drivers to ensure that their vehicles are parked correctly and do not obstruct others. Vehicles parked in compliance with the rules will not be issued a PCN. By following the displayed restrictions, drivers can avoid penalties and help maintain a safe, efficient road network.

# **Penalty Charge Notices (PCNs) Charging Levels**

Penalty Charge Notices (PCNs) are issued when parking regulations are breached. These contraventions are categorised by severity, which determines the level of the penalty:

- **Higher-level PCNs (£70):** Issued for more serious violations, such as parking on yellow lines.
- Lower-level PCNs (£50): Issued for less serious infractions, such as parking with an expired permit or pay-and-display ticket.

#### **Penalty Charge Notice (PCNs) Service Requirements**

Under the Traffic Management Act 2004, a PCN can be served in three ways:

#### 1. Affixed to the Vehicle

 The Civil Enforcement Officer (CEO) attaches the PCN to the vehicle, typically on the front windscreen or another visible location.

#### 2. Handed to the Driver

 The CEO hands the PCN directly to the individual who appears to be the driver.

#### 3. Issued by Post

- o This method is used in the following situations:
  - a. **Approved Device**: A contravention is detected using an approved camera system.
  - b. **Vehicle Drove Away**: The vehicle drove away before the CEO could serve the PCN by affixing it or handing it to the driver.
  - c. **Prevented from Issue**: The CEO was prevented from serving the PCN directly.

# Within 14 Days of the PCN Issue Date

- Discounted Payment Period:
  - You can pay the reduced charge (£25/£35).
  - After 14 days, this discounted rate is no longer available.
  - Submit an informal challenge.

# After 28 Days of the PCN Issue Date

- Notice to Owner Issued:
  - If the charge remains unpaid after 28 days, a Notice to Owner will be sent to the vehicle's registered keeper.
  - o The keeper must either:
    - Pay the full amount (£50/£70) within 28 days, or
    - Submit a formal representation.
  - o Failure to Respond:
    - If no action is taken, a Charge Certificate will be issued.

#### After 28 Days of the Notice to Owner Issue Date

- Charge Certificate Issued:
  - The charge increases by 50% (£75/£105).
  - Payment must be made within 14 days.
  - Appeals are not accepted at this stage.

# After 14 Days of the Charge Certificate Issue Date

- Debt Registration at the Traffic Enforcement Centre (TEC):
  - If the Charge Certificate is not paid, the debt will be registered with TEC, and a £10 registration fee will be added (£85/£115).
  - o An **Order for Recovery** will be sent to the registered keeper.
  - o The keeper must either:
    - Pay the outstanding amount within 21 days, or
    - File a witness statement.

# After 21 Days of Debt Registration

- Warrant Issued for Enforcement:
  - If no payment or witness statement is received, the TEC will authorise a warrant for debt recovery.
  - A certificated Enforcement Agent will be engaged to recover the debt, and additional fees will apply.

# **Traffic Management Act – for PCNs Served by Post**

For information on challenges, representations, and appeals, refer to Chapter 6.

#### Upon Receipt of the Postal PCN

- The PCN will be sent to the vehicle's registered keeper. At this stage, you have the following options:
  - o Pay the discounted charge within 21 days (£25/£35).
  - If the discounted charge is not paid within 21 days, pay the full charge within 28 days (£50/£70).
  - Make a representation to Reading Borough Council.

# After 28 Days of the PCN Issue Date

- Charge Certificate Issued:
  - If no payment or representation is made within 28 days, a Charge Certificate will be sent to the registered keeper.
  - The charge will increase by 50% (£75/£105).
  - Payment must be made within 14 days. Appeals are not accepted at this stage.

# After 14 Days of the Charge Certificate Issue Date

- Debt Registration at the Traffic Enforcement Centre (TEC):
  - If the Charge Certificate is not paid, the debt will be registered with the Traffic Enforcement Centre, and a £10 registration fee will be added (£85/£115).
  - An Order for Recovery will be sent to the registered keeper.
  - o The keeper must either:
    - Pay the outstanding amount within 21 days, or
    - File a witness statement disputing the order.

# After 21 Days of Debt Registration


- Warrant for Enforcement Issued:
  - If no payment or witness statement is made, the TEC will authorize a warrant for recovery.
  - A certificated Enforcement Agent will be engaged to recover the debt, and additional fees will apply.

# **Paying a Penalty Charge Notice**

Penalty Charge Notices (PCNs) can be paid online, by post, or by telephone. Once payment is made, the recipient (driver, owner, or hirer) accepts liability for the penalty charge and forfeits the right to challenge or make a representation against the PCN.

Reading Borough Council adheres to legislation which states that a recipient can either pay the penalty or challenge the PCN—but not both. This interpretation is supported by the House of Commons Transport Committee, ensuring clarity and fairness in the process.

The graph below illustrates the distribution of payment methods used by recipients to settle their PCNs.

# **Approved Device PCNs (Camera Enforcement)**

The approved devices are permitted to address specific contraventions, including school "keep clear" markings, bus stops or stands, red routes, and bus lanes.

During the 2023/2024 year, a total of 10,408 Parking Penalty Charge Notices (PCNs) were issued using the approved device as set out below.

#### **Red Route Enforcement**



From the 7<sup>th</sup> March 2018 the Council introduced its first red route in Reading, along the 'Purple 17' bus route. It was introduced first along the East of Borough starting on the Kings Road, at its junction with the IDR, following the A329 corridor east, through Cemetery Junction and along the Wokingham Road. It ends near to the Three Tuns crossroads, on the borough boundary.

The second part of the red route was introduced on the West of the Borough starting on the Oxford Road, at its junction with Alfred Street heading along all the Oxford Road, onto Norcot Road,

School Road and ending at Park Lane (at the junction with Mayfair). The final part was implemented in the Town Centre and joins the East and West red routes.

A Red route is a 'no stopping' restriction which has been successfully used on major bus routes in London for many years. It helps keep key public transport moving, minimises delays for bus passengers and improves safety for pedestrians and cyclists by preventing dangerous or illegal parking.

The Red Route restriction means where double red lines are marked, vehicles cannot stop at any time – Monday to Sunday – including for short periods of loading or unloading. Only disabled blue badge holders, Hackney Carriages (black cabs) and private hire vehicles licensed by Reading Borough Council are permitted to stop to allow for boarding and alighting. Emergency service vehicles will, of course, be permitted to stop on the Red Route

Enforcement is carried out by the Civil Enforcement Officers (direct issue) and the Council's enforcement (approved device) vehicle.

# **Chapter 4 – Bus Lane Enforcement**

Reading Borough Council has the highest density of bus lanes per mile of road in the UK, with a greater proportion of residents using buses compared to many other towns and cities. The Council, alongside its partners, is committed to ensuring public transport remains reliable and punctual. Properly functioning bus lanes play a key role in reducing journey times, improving reliability, and making public transport a more appealing option, which can help alleviate traffic congestion.



However, misuse of bus lanes undermines their effectiveness. Vehicles that disregard bus lane restrictions can delay public transport and increase the risk of accidents by catching other road users off guard.

In October 2005, Reading Borough Council was granted powers under the Transport Act 2000 to enforce bus lane regulations. These powers were updated in May 2022 to align with the Traffic Management Act 2004, bringing bus lane enforcement in line with parking regulations.

Under the new legislation, a six-month warning period is required when enforcement begins for any new bus lanes. If a vehicle contravenes the same bus lane again within two weeks of receiving the first warning notice, a Penalty Charge Notice (PCN) may be issued during this six-month period. After the six months, warning notices will no longer be issued, and PCNs will apply directly.

In 2023/2024 period the following warning notices were issued:

While the Police retain the authority to act against drivers contravening bus lane rules or ignoring traffic signs, Reading Borough Council's enforcement through approved camera devices significantly increases the likelihood of detecting and addressing bus lane contraventions.

Drivers caught misusing a bus lane may receive a £70 PCN. Camera systems record bus lane activity, and enforcement officers review the footage to confirm whether a

contravention occurred or if there were mitigating circumstances, such as avoiding an accident.

Recipients of a PCN have the right to challenge it by submitting a representation within 28 days of issue. This ensures a fair opportunity for drivers to contest the penalty if there are valid reasons for the contravention.

# **Bus Service Improvement Plan**

The Government launched the National Bus Strategy – Bus Back Better, in March 2020, setting an ambitious vision to dramatically improve bus services across England. The strategy places a requirement on all Local Transport Authorities to prepare a Bus Service Improvement Plan (BSIP), working in partnership with local bus operators and neighbouring local authorities.

The first Bus Service Improvement Plan (BSIP) for Reading is published on the Council's website (link below). This outlines our overarching vision and ambitions for buses in the town. The plan identifies key areas for improvement in the local bus network, building on our strong track record of having the second highest level of bus usage in the country outside of London (per head of population) before the Covid pandemic.



  - A certificated Enforcement Agent will be engaged to recover the debt, and additional fees will apply.

# **Chapter 5 – Moving Traffic Enforcement**

Part 6 of the Traffic Management Act (2004) was enacted in May 2022 which allows Local Authorities outside of London to enforce against specific moving traffic offences. These rules were previously only enforced by the police under criminal law. Reading Borough Council acquired these powers, which enables the Council to expand the work it already does enforcing against unlawful and dangerous parking, and misuse of bus lanes.

Reading Borough Council will use these new powers to improve safety and tackle congestion by enforcing moving traffic offences, such as:

- driving through a 'No Entry' sign
- turning left or right when instructed not to do so (making banned turns)
- entering yellow box junctions when the exit is not clear.
- driving where and when motor vehicles are prohibited.
- driving on routes that are for buses and taxis only.

In February 2023 enforcement of yellow box junctions commenced. Yellow box junctions keep the junction clear and keep traffic on the roads flowing. Vehicles are not permitted to stop in a box junction except for turning right and are prevented from doing so by oncoming vehicles or other cars waiting to turn right as well.



Warning notices must be issued for the first six months when enforcement commences. If a vehicle contravenes the same yellow box junction after two weeks of the first warning notice, a PCN can be issued in that 6-month period. After 6 months the warning notices stop and PCNs can be issued.

In 2023/2024 period the following warning notices were issued:

# Upon Receipt of the Postal PCN

- The PCN will be sent to the vehicle's registered keeper. At this stage, you have the following options:
  - o Pay the discounted charge within 21 days (£35).
  - If the discounted charge is not paid within 21 days, pay the full charge within 28 days (£70).
  - Make a representation to Reading Borough Council.

#### After 28 Days of the PCN Issue Date

- Charge Certificate Issued:
  - If no payment or representation is made within 28 days, a Charge Certificate will be sent to the registered keeper.
  - o The charge will increase by 50% (£105).
  - o Payment must be made within 14 days.
  - Appeals are not accepted at this stage.

# After 14 Days of the Charge Certificate Issue Date


- Debt Registration at the Traffic Enforcement Centre (TEC):
  - If the Charge Certificate is not paid, the debt will be registered with the Traffic Enforcement Centre, and a £10 registration fee will be added (£115).
  - o An **Order for Recovery** will be sent to the registered keeper.
  - o The keeper must either:
    - Pay the outstanding amount within 21 days, or
    - File a witness statement disputing the order.

# After 21 Days of Debt Registration

- Warrant for Enforcement Issued:
  - If no payment or witness statement is made, the TEC will authorise a warrant for recovery.
  - A certificated Enforcement Agent will be engaged to recover the debt, and additional fees will apply.

# Chapter 6 - Challenges, Representations and Appeals

If a driver believes a Parking Penalty Charge Notice (PCN) has been issued unfairly, they have the right to challenge it through a three-stage process:

#### 1. Informal Challenge

For PCNs issued directly (e.g., affixed to the vehicle or handed to the driver), the first step is to submit an informal challenge to Reading Borough Council. This stage does not apply to PCNs issued by post, such as those related to parking, bus lane, or moving traffic contraventions.

# 2. Formal Representation

 If the informal challenge is unsuccessful (or for PCNs issued by post), the next step is to submit a formal representation to the Council.

# 3. Appeal to the Traffic Penalty Tribunal

 If the formal representation is rejected, the driver can appeal the decision to the independent Traffic Penalty Tribunal.

Each case is reviewed individually by the Reading Borough Council Parking Services team, which considers the evidence provided by the Civil Enforcement Officer alongside any additional information submitted by the driver.

While statutory time limits apply to the processing of formal representations and appeals, guidance is followed for responding to informal challenges. The Council is committed to handling all challenges, representations, and appeals efficiently, effectively, and impartially to ensure a fair process for all parties.

# Stage 1 - Making an Informal Challenge

Reading Borough Council Parking Services reviews all informal challenges to Penalty Charge Notices (PCNs). If a challenge is made within 14 days, the discount period is paused until reviewed. Challenges can be submitted promptly in writing or via the Council's secure website. Successful challenges result in PCN cancellation, while unsuccessful ones allow an additional 14 days to pay at the discounted rate.

# Stage 2 - Representations

Representations can be made after receiving a **Notice to Owner**, sent to the DVLA registered keeper, if the PCN remains unpaid. Representations must be submitted within 28 days, and the Council has 56 days to respond; if they fail to respond, the PCN is cancelled. For PCNs issued by post, the process is similar, with representations allowed within 28 days. If rejected during the discount period, the discounted rate is usually re-offered unless appealed to the Traffic Penalty Tribunal, which forfeits the discount. This process is defined by the Traffic Management Act 2004 and is the only way to contest a PCN.

# Stage 3 - Appeal to the Traffic Penalty Tribunal

The Traffic Penalty Tribunal operates independently from the Council. Adjudicators, who have at least five years of legal experience, review the evidence for appeals against Penalty Charge Notices issued by Local Authorities. Their decisions are final and binding on both parties.

If a representation to the Council is unsuccessful, a Notice of Appeal will be sent to the registered keeper, including details on how to appeal online. An appeal to the Traffic Penalty Tribunal can only be made if the Council has rejected the representation.

The Tribunal's online appeals portal ensures that appeals are processed swiftly. It allows appellants, the Council, and Adjudicators to easily review evidence, communicate, and make decisions.





The Council reviews all adjudicator decisions and uses their feedback to prevent unnecessary appeals. Each case is re-evaluated when an appeal is registered, regardless of the initial decision.

The Tribunal has transitioned to an online portal, enabling appellants to register, upload evidence, and track their appeals online. Appellants can still opt for their appeal to be decided by post, telephone, or in person, with most choosing post or telephone. The Council can upload evidence and communicate with the Tribunal and appellants, enhancing efficiency and allowing Adjudicators to make quicker decisions.

# **Chapter 7 – Witness Statements**

#### In Time Witness Statements

When a Penalty Charge Notice (PCN) remains unpaid, the Council can register it as a debt with the Traffic Enforcement Centre. This results in an Order for Recovery being issued, with a £10 registration fee added to the PCN charge

When the recipient receives the Order for Recovery, they have 21 days to either:

- 1. Pay the charge.
- 2. File a Witness Statement

A **Witness Statement** is a legal document submitted to assert that something may have gone wrong during the process of serving the documents or the recipient believes they have paid the charge. It is not an appeal against the PCN itself.


There are only **four grounds** on which they can be made:

- 1. You did not receive the notice to owner/penalty charge in question.
- 2. You made representation about the penalty charge to the local authority concerned within 28 days of the service of the notice and you did not receive a rejection notice.
- 3. You appealed to the Adjudicator against the local authority decision to reject your representations within 28 days of the service of the rejection notice but you have not had a response to your appeal.
- 4. The penalty charge notice has been paid in full.


Filing a Witness Statement can temporarily halt enforcement and reset the process, allowing the case to be reviewed. However, it is critical to ensure that the grounds for the Witness Statement are valid, as submitting false or incorrect information could have legal consequences.

A Witness Statement filed within the 21 days is known as an "In Time" Witness Statement.

The graph below shows the total number of In Time Witness Statements received.



The graph below shows the number of In Time Witness Statements processed by the grounds.



Once a Witness Statement has been filed at the Traffic Enforcement Centre (they are not processed by the Council), they will issue a **Revoking Order**.

The Revoking Order is sent to the Council (& recipient), and on receipt they will do the following:

- Revoke the Order for Recovery & Charge Certificate.
- Re-set the charge i.e., to £50 or £70.

A Revoking Order does not cancel the PCN. The Council can continue enforcement, with next steps depending on the grounds declared in the Witness Statement:

**Ground 1** – A new PCN or Notice to Owner is sent to the recipient. This allows them to either pay or make representation again. The PCN cycle is re-set.

**Ground 2/3/4** – they are sent a "payment letter" offering 14 days to pay the full charge (not the discounted amount) to close the case.

If no payment is made, the case is referred to the Traffic Penalty Tribunal for review, resulting in one of two outcomes:

- **Enforce**: The Adjudicator decides to continue enforcement. The recipient must pay within 28 days, or a Charge Certificate will be reissued.
- Cancel: The Adjudicator cancels the PCN, and no further action is required.

# **Out of Time Witness Statements**

If the recipient misses the 21-day deadline to file a Witness Statement, they can submit an "**Out of Time" Witness Statement** using forms provided by the Traffic Enforcement Centre (not the Council). This includes a TE7 form explaining the delay. This is not an appeal against the PCN.

The Traffic Enforcement Centre decides to either:

- 1. **Accept**: A Revoking Order is issued, and the Witness Statement is treated as "In Time."
- 2. **Refuse**: Enforcement action continues, and payment is required.

Most Out of Time Witness Statements are accepted because recipients often have valid reasons for filing late. The most common reason is a change of address, which results in them not receiving the original notices.

### N244 – Application Notice to set aside the Court Order

If the Traffic Enforcement Centre has refused the Out of Time Witness Statement, the recipient can ask for this decision to be set aside at the Local County Court, whereby a Judge will consider the application.

To apply an **Application Notice N244** must be completed along with the Court fee, the court fee depends on the type of application being made.

The Judge will consider the application and make the following determination:

- Accepted means an In Time Witness Statement will be processed.
- Refused means Enforcement action continues, and payment is due.

### **Chapter 7 – Enforcement Agents**

If a Penalty Charge Notice (PCN) remains unpaid after the Council has issued the statutory notices, a Warrant may be issued to Enforcement Agents (previously known as bailiffs) to recover the debt. In April 2014, the regulations governing Enforcement Agents and their fees underwent significant changes.

This reform came with the implementation of new legislative measures under the Tribunals, Courts and Enforcement Act 2007. A key change was the introduction of a simplified fee structure for Enforcement Agents at each stage of the recovery process, as outlined in the Taking Control of Goods (Fees) Regulations 2014.

Regulations 4 and 5 of these provisions authorise Enforcement Agents to recover fees from the debtor and define the specific stages of the enforcement process. Schedule 1 specifies the relevant fees, which are, as follows:

Stage	Fee	Information
Compliance Stage	£75	Notifying the debtor in writing, on receipt of the warrant, of the liability.
Enforcement Stage	£235	For attending the premises, if no payment is made within 7 clear days of the compliance stage notice. The Enforcement Agents can make several visits but only one charge is applied.
Sale/Disposal Stage	£110	For preparing to remove goods, removing goods, sale of goods

There may be additional charges if goods are removed such as storage, auction costs etc.

If there are multiple warrants issued, the compliance fee is charged per warrant, but the enforcement and sale/disposal fee is normally only added onto the first warrant. There are exceptions to this and for further information please see below.

The Council expects Enforcement Agents, acting in respect of debts it (the Council) has registered, to handle enquiries or complaints about the fees those agents have charged. The Taking Control (Fees) Regulations 2014 provides for any disputes about the fees to be settled by a Court.

## Chapter 8 - Permits



Permit Parking Zones were introduced in Reading in the mid-1970s to help residents park in their streets, which might otherwise have been occupied by shoppers or commuters heading to the town centre. Over time, as car ownership and traffic patterns have evolved, these zones have expanded from central Reading to other areas of the town affected by parking issues.

The permit parking service and zoning system have been updated to accommodate these changes, with larger zones and a better balance between the number of permits issued and the availability of on-street parking spaces. Residents are encouraged to regularly check signs and road markings, as changes to the permit scheme are periodically made.

Currently, there are three main types of permits available: resident, visitor, and business. Additionally, temporary permits and other discretionary permits are offered. The Council must be satisfied that the same conditions apply for discretionary permits and there is no automatic right of renewal.

The Council is transitioning to a digital permit system, where permits are linked to Civil Enforcement Officers' handheld devices and checked during patrols, eliminating the need to display them in vehicle windscreens. However, any physical permit issued must still be clearly displayed in the windscreen when parking in a permit bay, ensuring it can be easily read.

#### **Resident Permits**

Resident Parking Permits are provided in controlled parking areas for residents of Reading. Following an extensive consultation, parking zones were simplified and reorganised providing a longer and more flexible parking solution. Permits will run for 12 months from the date of issue, and it is up to the user to renew a permit before it expires.

A maximum of two permits are available to be issued per household. To comply as a household the house or flat must; lie within a Permit Parking Zone, be registered for Council Tax, have appropriate planning permission, and not have a planning condition that prohibits the issue of permits.

The first permit per household is £48 and the second is £180. It is down to the discretion of the homeowner as to what name goes on which permit. When first applying for a permit, proof of residence and proof of car ownership will be required. Once a permit has been granted, it can be renewed the following year online without the need for re-applying or supplying evidence.

### **Business Permits**

Business Parking Permits are available to businesses that operate within a permit parking zone. The criteria to be eligible for a Business Parking Permit are the staff and operators may not reside in the permit zone, the premises must have no associated off-street parking, and the staff for whom the permits are intended for should require regular and frequent use of their vehicles during the working day.

Businesses are eligible to apply for one permit per business with any further requests to be made as a discretionary application. When applying for a permit, the business must provide proof of address and proof of vehicle ownership.

### **Visitor Permits**

Both residents and businesses within permit parking areas can offer visitor permits. All households in permit' parking zones are entitled to visitor permits. Visitor permits are scratch cards each for half days. They are issued in books of 20 permits. The first two books are free and a further five books are available at a cost of £26 per book. Proof of residence is required when applying for visitor permits.

Businesses are able to purchase up to 100 visitor permits, Community Agencies are able to purchase an unlimited number of visitor permit.

Like with the Residents' visitor permits Business visitor permits are scratch cards for half a day and are also issued in books of 20 at £26 per book.

#### **Temporary Permits**

Temporary permits can be obtained through our online service and are normally issued to residents who have just moved into the permit zone or have changed their vehicle. Temporary permits are issued for 8-weeks to allow time to submit full proofs. Temporary permit cover is not extended after the 8-week period as it is felt this is enough time to have obtained the full proofs required.

### **Discretionary Parking Permits**

Reading Borough Council has recognised that there are those who, from time to time, may have business within the permit zones which, the Council may decide at its discretion as the Highway Authority to be legitimate reason to grant a permit.

Other such permits that the Council issues include Medical Practitioners, Healthcare Professional, Carer, Charity, Tradesperson, Teacher, Nanny and Other Resident/Business/Visitor Discretionary.

# Chapter 9 - Blue Badges

Blue Badges provide a vital lifeline to over 2.5 million people every year allowing disabled people to access employment, shops, and other services. Blue Badge fraud is a growing issue across the country. Abuse of the scheme means that priority spaces are unable to be used by those who need them most.



It is therefore vital that Reading Borough Council put measures in place to try and reduce the number of incidences of Blue Badge fraud.

Since the 1<sup>st</sup> January 2012, the Department for Transport (DfT) has introduced a new Blue Badge Improvement Service (BBIS) scheme which is intended to tackle this problem. The scheme comprises of a central nationwide database and a new assessment process to ensure badges only go to those who need them. The scheme will be managed nationally by Northgate Public Services.

The new Blue Badges nationally use security style inks and techniques making them almost impossible to reproduce, tamper with or amend. It is now an offence for anyone who is not the actual badge holder to use the Blue Badge, or to park in an on-street Blue Badge parking bay without displaying a badge.

If you suspect someone of committing Blue Badge fraud you can report to the Corporate Investigations Team in confidence (details in further information).

The Department for Transport has issued a booklet called 'The Blue Badge Scheme: Rights and Responsibilities in England.' This booklet explains to the holder of a Blue Badge their responsibilities, places where they can and cannot park, and further travel advice. This also includes information on how to display the badge, where parking is for free and where time limits do/do not apply.

#### **National Fraud Initiative**

The purpose the National Fraud Initiative is to recover those Blue Badges which should have been returned following a death. Reading Borough Council is part of this initiative. Following the national redesign of Blue Badges, it should make it easier for Local Authorities to both cross check and identify fraudulent badges.

The Corporate Investigations Team (CIT) and Trellint have been jointly undertaking regular drives across the Town Centre where both services look at Blue Badge parking bays and monitor any misuse or fraud.

## **Chapter 10 - Signs and Lines Maintenance**

Reading Borough Council's Streetcare Services handles the maintenance of road signs and markings. Neighbourhood Officers (formerly Highway Inspectors) conduct safety inspections to identify and order repairs for issues like faded markings or missing signs. Inspection frequency depends on road classification:

A-class roads: Monthly

• B- and C-class roads: Quarterly

Unclassified roads: Annually

Defects reported by Civil Enforcement Officers, Ward Councillors, or the public are also addressed. Officers additionally inspect direction signs, road surfaces, cycleways, footways, and gullies, and repair street lighting through monthly night patrols.

**Resurfacing work**, typically conducted in summer, may temporarily obscure markings, which are replaced as soon as possible. **Snow and ice** can also cover markings, especially on ungritted residential roads, but parking restrictions remain enforceable per the relevant Traffic Regulation Order. On the principal roads and the main bus routes gritting is undertaken in accordance with the Winter Service Plan.

Penalty Charge Notices are issued only if lines and signs are in an acceptable condition. While wear and tear are inevitable, the Council ensures compliance with Regulation 18 of the Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996, maintaining clear markings and signs to provide motorists with adequate information about restrictions.

'Where an order relating to any road has been made, the order making authority shall take such steps as are necessary to secure a) ... the placing on or near the road of such traffic signs in such positions as the order making authority may consider requisite for securing that adequate information as to the effect of the order is made available to persons using the road'.

## Chapter 11 - Car Parks

The current parking strategy, part of the Local Transport Plan, focuses on encouraging short-stay parking in central Reading while limiting long-stay/commuter parking near the town centre. Pricing is designed to reflect peak road demand and promote sustainable alternatives like park-and-ride facilities.



Since October 2018, Reading Borough Council has managed its own off-street car parks. Ongoing investments aim to improve customer experience while maintaining value for money.

The Council regularly reviews parking tariffs. Season tickets are available for several car parks, including Broad Street Mall, Queens Road, Cattle Market, Recreation, Dunstall Close, and Chester Street, with options for annual, 3-month, and 1-month durations (except Dunstall Close and Chester Street, which only offer annual permits).

# Chapter 12 - Pay and Display

On-street pay and display offers alternative short-term parking for the Town Centre. The bays are located across the town centre and around the Hospital/University area. The bays provide more flexible parking options for visitors.





There are now over 1,000 spaces spread across Reading:

Pay and display bays are an effective parking management tool that increases the turnover in spaces around the Town Centre and other local community facilities.

In line with the Department for Transport under 'The Blue Badge Scheme: Rights and Responsibilities in England,' holders of the blue badges can park for free and without time limit in the pay and display bays. However, in the shared use bays it is only for free and without limit during the hours a pay and display ticket is required, outside of the hours a parking permit is required.



# Chapter 13 - Freedom of Information

The Freedom of Information Act came into effect in January 2005. This requires Reading Borough Council to provide information which is held available to the general public. The Freedom of Information Act requires that Reading Borough Council respond to requests within 20 working days. Reading Borough Council is only required to respond with information that is held - it does not require the Council to analyse the information.

The graph below shows the number of Freedom of Information requests received by the Reading Borough Council Parking Services team. In 2022/2023, a total of 54 Freedom of Information requests were received.



The Reading Borough Council Parking Services team frequently receives a high volume of Freedom of Information (FOI) requests from motorists who have been issued a Penalty Charge Notice (PCN). These requests typically seek information about PCNs issued in specific locations. While the team aims to respond within 20 working days, some requests are too broad, lacking details such as date ranges, specific types of challenges, or focusing on PCNs issued to non-Reading based motorists.

When a manual search of each PCN is required, it can take between 30 seconds to 2 minutes per investigation. Given that Reading Borough Council holds thousands of records, fulfilling such broad requests would exceed the 18-hour time limit, making them exempt from processing. The table below illustrates some of the most common FOI requests received.

### **Chapter 14 - Financial Information**

The Statutory Guidance mandates that for good governance, enforcement authorities must forecast revenue in advance. However, generating revenue should not be the goal of Civil Parking Enforcement, and authorities are prohibited from setting revenue targets or quotas for Penalty Charge Notices.

The primary aim of penalty charges is to deter motorists from contravening parking and traffic restrictions. Any payments received, whether from on-street or off-street enforcement, must be used in accordance with Section 55 (as amended) of the Road Traffic Regulation Act 1984. This Act restricts the purposes for which a Local Authority can use any surplus income from on-street parking. The Traffic Management Act later amended these restrictions, allowing Councils that do not need additional off-street parking to use any surplus for general transport measures and other lawful expenditures.

Reading Borough Council has observed increased compliance with parking and bus lane restrictions over the years.

In line with the Data Transparency Code, it should be noted that the surplus has contributed to fund initiatives such as concessionary bus passes for the ReadiBus service and other measures as defined under Section 55 of the Road Traffic Regulation Act, as detailed in the table below. In 2023/2024 the surplus totalled £6.334M.
