## **Examination of the Reading Borough Local Plan Partial Update: Stage 2 Hearings**

I am writing to you as you submitted a representation on the Pre-Submission Draft Local Plan Partial Update, a consultation on which was held under Regulation 19 of the Town and Country Planning (Local Planning) (England) Regulations 2012 during November and December 2024.

The Local Plan Partial Update (LPPU) was submitted to the Secretary of State on 9<sup>th</sup> May. Following submission, Planning Inspector Joanna Gilbert MA (Hons) MTP MRTPI was appointed to carry out the independent examination of the LPPU.

We have previously written to you to advise you of Stage 1 hearings as part of the examination, which were held on 11<sup>th</sup> and 12<sup>th</sup> November covering the following matters:

- · Matter 1: Legal requirements and procedural matters; and
- Matter 2: Housing need and requirement.

The Inspector's letter following the Stage 1 hearings is available on the LPPU examination webpage: Local plan examination - Reading Borough Council (reference EX030).

Stage 2 hearings to cover all outstanding matters will be held on 3<sup>rd</sup> - 6<sup>th</sup> and 10<sup>th</sup> - 12<sup>th</sup> February 2026. These will cover the following matters

- Matter 4: Cross-cutting policies
- Matter 5: Built and natural environment
